


## ORDER

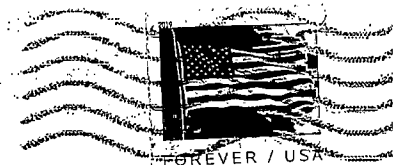
