RE: Follow up request for response from Ms. Allen to letter(s) dated 13 March 2019

Ms. Allen,

You sent me two letters dated 13 March 2019 which were contained in one envelope which was also post marked 13 March 2019.

I responded to those letters via a motion sent post marked 23 March 2019.

As of today, a month after my motion was sent and received, you have not responded to a couple of obvious issues raised in that motion, of which a response from you was obviously implied as well as totally expected. Additionally, the same issues were raised in my response to Ms. Trotter's response of 1 April 2019, filed 11 April 2019.

This certified letter is being sent to you to request a response from you to at least one of those issues by close of business this coming Monday, 29 April 2019.

The second letter of yours dated 13 March 2019 was a response by you, apparently on behalf of Judge Lochemy, related to my Canon 3 request of Judge Lochemy dated 17 February 2019. Specifically related to that letter / response, please reply to all with all information that you relied upon to justify responding on behalf of Judge Lochemy. Of specific interest, at the time of your response dated 13 March 2019, were you officially retained by Judge Lochemy, or retained by some other Person on Judge Lochemy's behalf, to represent Judge Lochemy in responding to my request of Judge Lochemy dated 17 February 2019? If so, please provide any relevant information of that nature by USPS actually deposited and post marked in the USPS by close of business 29 April 2019.

Thank you for your prompt attention to this matter on Monday. If you believe you need to have someone respond on your behalf to this request, please have that person either provide the requested information and explanation by the same time on Monday, 29 April 2019, or otherwise, if that

person does not believe it is in yours or the Court of Appeals or the State's best interest to do so, please have that person respond by close of business Monday with some response of that nature, along with any appropriate reference to State or Federal law they are relying on to assert that position on your behalf.

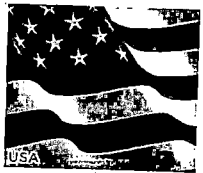
