Between them, the Nationwide Appellants have submitted two substantially identical “Petition[s] for Review Pursuant to Rule 241(d)(2) and (d)(7), SCACR” (the “Nationwide Petitions”).

The Nationwide Petitions follow—and are themselves substantially identical to—Appellant Builders Mutual Insurance Company’s (“Builders Mutual”) “Petition Pursuant to Rule 241(d)(7), SCACR on behalf of Appellant Builders Mutual Insurance Company to Review Circuit Court Order Lifting Appeal Stay” (the “Builders Mutual Petition”).

Plaintiffs-Respondents, Palmetto Pointe at Peas Island Condominium Property Owners Association, Inc., and Jack Love, Individually, and on behalf of all others similarly situated (collectively, “Plaintiffs”), have already responded to the Builders Mutual Petition via “Plaintiffs-Respondents’ Return to Petition of Appellant Builders Mutual Insurance Company for Review of Circuit Court Order Lifting Stay and/or Cross-Motion to Dismiss Appeal, Grant Limited Remand, or Otherwise Confirm that Trial May Proceed as Scheduled” (“Plaintiffs’ Opposition to the Builders Mutual Petition”).

WHEREFORE, for the reasons set forth in Plaintiffs’ Opposition to the Builders Mutual Petition (which are incorporated herein by reference, and which, Plaintiffs respectfully submit, amply rebut Builders Mutual and the Nationwide

Appellants' positions²), Plaintiffs ask the Court to deny the Nationwide Petitions, too, and/or grant Plaintiffs' cross-motion (which, though made in Plaintiffs' Opposition to the Builders Mutual Petition, seeks relief that is case wide in scope) as may be necessary for the circuit court (the Honorable Jennifer B. McCoy, presiding) to proceed as scheduled with the trial of this case set to begin May 6, 2019.

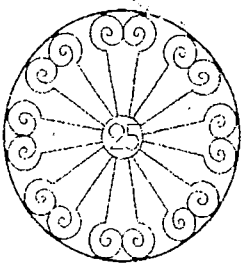

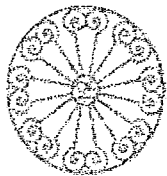

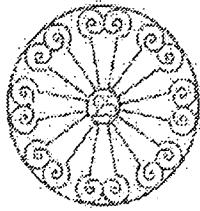
