Appellant would respectfully request to dismiss this Appeal. In support of this motion, counsel would respectfully show the Court the following:

1. On December 1, 2017 Appellant plead guilty to two counts of Domestic Violence Second Degree.
2. On April 26, 2018, Defendant entered a plea of guilty to resisting arrest and was sentenced to 1 year. This conviction was a violation of Defendant's probation. Judge Addy revoked Appellant's probation and sentenced Defendant to 6 years on the probation violation.


