Comes now the Appellant, pro se, and states the following;

As of the date of this filing, Respondent, Gateway Mortgage Group LLC [Gateway], has refused to provide Appellant with a copy of the transcript not required at the time of Appellant's Initial Appeal of Judgment and Orders. The transcript in questions is from an illegal hearing presided over by R. Thayer Rivers Jr., co-counsel for Respondent, and in lieu of the three (3) jury demand's made by Appellant in writing which were denied by R. Thayer Rivers Jr. and which are included in Appellant's Designation of Matter.

In its Motion for Relief from Stay, dated Nov 14, 2018, Respondent, [Gateway], evidenced to the US Bankruptcy Court District of South Carolina that it obtained a lien on Ms. Coffey's home on Sept 21, 2016, through illegal means. Neither Beaufort county nor Respondent, [Gateway], felt compelled to inform Appellant about this illegal lien, as evidenced in every single filing by Appellant which appears in her Designations of Matter(s), and Appellant did not know about this illegal lien until Nov 16, 2018, when she received Respondent's filing to the federal court.

Until Sept 21, 2016, Appellant, as a matter of Probate through Jim Grimsley and the Probate Court of Beaufort County, South Carolina, did own her home outright and exclusively. Respondent [Gateway] had no cause to file any suit against Appellant. Respondent, [Gateway], merely invented a reason to sue Appellant through an ill-gotten lien on Appellant's home through illegal professional courtesy, and filed suit in Beaufort County, South Carolina.

Appellant, Ms. L.E. Pauli Coffey [Ms. Coffey], is not Respondent's volunteer victim nor is she Beaufort County, South Carolina's volunteer victim.

In October 2010, Appellant, [Ms. Coffey] suffered from a crushed leg and crushed back. For more than three (3) months, [Ms. Coffey] was denied medical care for her injuries because a very sick individual made the overt decision to make [Ms. Coffey] his volunteer victim. As was determined through investigation in 2013, this deranged individual used his badge as currency to obtain illegal access to Ms. Coffey's phone calls and phone records. This sadistic, sick individual listened as Ms. Coffey called, many times each day, begging and crying and, at times, screaming for care for her crushed leg and back. Her care was denied, because of a badge.

In February 2011, and by her own devices, [Ms. Coffey] was able to obtain care despite this sick individual who found joy, laughter and completion in listening to a person suffer in excruciating pain and suffer through life trying to care for a child while suffering from extreme injury, but it was too late. The medical professionals could only

report that the bone in [Ms. Coffey's] leg had healed over and calcified in the shape in which it was crushed. Several surgeries proved useless to fix [Ms. Coffey's] leg. The drive to Columbia leaves [Ms. Coffey] in excruciating pain.


As a direct result of a demented, deranged individual who happened to have a badge, [Ms. Coffey] lost her business and lost her ability to generate income from those jobs available to someone with little more than a high school education.

Gateway v. Coffey was an illegal suit on the day it was filed. Merely maliciously, wantonly and wrongfully titling [Ms. Coffey] as a debtor and mortgagor, when she has never been either, does not give Gateway the right, in any state, to file any suit against [Ms. Coffey]. Beyond inventing cause to file suit against [Ms. Coffey], Respondent, [Gateway] has habitually ignored and defied every law, state code and practice, required by the state of South Carolina and the US Constitution, in its' way in order to continue its' illegal cases against Appellant, [Ms. Coffey], and it has done so with the apparent blessing of the state of South Carolina. No law support's the Order and Judgment from [Gateway's] attorney/ Special Referee R. Thayer Rivers Jr. to allow a mortgage reformation/ total rewrite without the inclusion of any borrower. All law before Thayer Rivers' illegal Judgment and Orders barred Respondent's suit and Thayer's Order and Judgment.

Appellant, [Ms. Coffey], is not South Carolina's volunteer victim any more than she was the volunteer victim of a deranged person with a badge in Indiana. Please stop victimizing me.
