

**NOTICE OF APPEAL**

Yolanda Shatten, by and through her undersigned attorney, appeals the jury verdict entered in her case in a trial before the Honorable Bentley Price on May 7, 2019 (received on May 7, 2019) imposing concurrent five (5) year sentences on the charges of Forgery and Practicing Law Without a License, (filed May 12, 2005 with the Clerk of Court for Richland County) and imposing a restitution of Ten Thousand six hundred Forty dollars (\$10, 640.00). The State action for Forgery and Practicing Law Without a License was premised upon the assertion that Appellant was not allowed to enter into a Lease to own arrangement with a tenant for property owned by appellant without the assistance of a licensed attorney. The trial judge erred when he denied Appellant's request to proffer her Income Tax Return as evidence of the State's witness's blatant and willful perjury in denying that she prepared tax returns involving property when she prepared the proffered return. That exclusion of the proffered evidence allowed the State's witness to work a fraud upon the Court which polluted the administration of justice and was likely outcome determinative. Appellant received written notice of the entry of this Order on May 7, 2019.


