Unfortunately the transcript request was returned and cancelled because it was stated in an email to me on April 10th, 2019 the money order was not signed.

April 10th, 2019 I sent an email to Mona Manley requesting an update regarding the transcript as the 60 day deadline was near. Extension granted February 22, 2019.

April 10th 2019 she email back to me the request and money was returned because the money order was not signed.

Noted: I did not receive her mailed letter stating the transcript request could not be completed and as such cancelled including the returned money order,

Previously we had communicated through email and I had left her a message; noted, an email or call

As stated the only documentation the transcript was cancelled and could not be fulfilled is on a returned email after I requested an update on the Transcript delivery on April 10th, 2019.

The 1st extension granted was predicated on and time lined on the transcript, the cancellation request was not reported to the Appellant Court and filed in SCCourts.org

I am requesting a 2nd extension of the transcript delivery because the 1st was cancelled and I was not properly notified and did not receive the notice from Mona Manly including the money order for \$106.25.

Points of Reference: I have submitted 10+ money orders to the Jasper County Courts and South Carolina Court of Appeals and all have the proper signature.

I have enclosed a CASHIER's check that requires NO SIGNATURE for \$106.25

Also, I emailed her on April 15th, 2019 and called her twice leaving messages regarding any expedite fees I could pay to process the transcript more timely. To date I have not received an email or returned phone call

I included an additional \$100.00 SIGNED money order for her to process the transcript in a more timely manner assuming it is an option.
