The undersigned counsel would respectfully request an order allowing him to file a petition for writ of certiorari in this case in excess of the twenty-five page limit imposed by Rule 243(e)(3), SCACR. In support of this motion, counsel would respectfully show the Court:

1. The petition for writ of certiorari and the appendix in this case are due on February 14, 2013. The appendix is over five thousand pages, and numerous meritorious issues were raised during the post-conviction hearing.


2. Counsel does not think that justice to the highly unusual facts of this case can be done in the twenty-five pages authorized by Rule 243(e)(3), SCACR.


