Dear Ms. Kitchings:

The Initial Brief of Appellant in this case is due tomorrow. Unfortunately, due to scheduling issues, and ongoing problems with my hip, I have not been able to complete this brief. As I have previously advised you, I have developed a large cyst in my right hip and have been in a good bit of pain for months. That pain has significantly worsened in recent months. Fortunately, the problem with my hip is readily repairable. I am scheduled for hip replacement surgery June 7, 2019. The surgeon will excise the cyst, do a bone graft and the hip replacement all at the same time and remarkably, they are doing it outpatient. I am expected to be able to work from home within a week; I should be back at my office shortly thereafter and will be able to resume Court appearances within a few weeks. Until I have the surgery, however, I am in a lot of pain and simply have not been able to work at the pace I normally maintain. For that reason, I now need to request a third, thirty (30) day extension for this stage of this appeal. I am enclosing a doctor's excuse from my orthopedic surgeon. While I certainly hope, after forty (40) years of practice, the Court would take my word for this, I thought it best to document this medical issue since this is a third request. I have discussed this request with William M. Blich, Jr., Senior Assistant Attorney General, and he has graciously consented to my request.

As always, I would note that I no longer have associates in my firm and therefore, have no other lawyers in my office to sign off on the necessity for this request. Hopefully the note from my surgeon will suffice. Even though he has consented, a copy of this request will be mailed to Mr. Blich today. Thank you very much for your time and assistance in this matter. I remain,





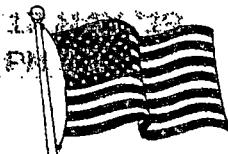
