Dear Ms. Kitchings:

I am writing to advise the Court of the status of the outstanding post-trial motions in the above captioned case as instructed in your letter dated April 17, 2019. As you are aware, I have been having a difficult time with my hip over the last year and that problem has gotten exponentially worse in the last several months. I enclose a copy of a note from my orthopedic surgeon verifying that I am currently scheduled for a total hip replacement on June 7, 2019. The large cyst in my right hip will be excised and a bone graft done at the same time. I have kept working through this ordeal; however, in the last few months the pain caused by the damage to my hip is simply too severe for me to work my usual hours and when I am working, I am simply not able to concentrate for long periods of time. I consider myself blessed that this is a problem that can be readily repaired and I am expected to make a fairly quick and total recovery.

For now, the Honorable R. Markley Dennis, Jr., Presiding Circuit Court Judge, has been kind enough to delay scheduling the hearing on these outstanding post-trial motions until after I recover from my surgery. I apologize to the Court and everyone involved for this delay, but it is simply beyond my control. I hope to be working from my home office within a week after my surgery. I am expected to be cleared to drive and return to court duties approximately one month after my surgery. I am hopeful that date might be sooner if I am fortunate enough to make a swift recover. I will certainly keep the Court posted. Thank you for your assistance in this matter. With my regards as always, I remain,

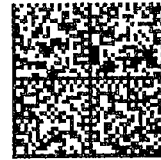
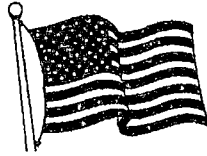
