**CONSENT MOTION FOR SUBSTITUTION OF COUNSEL**


NOW COMES Covil Corporation, Appellant in the above-captioned matter, and shows the Court as follows:

substitute Ashley K. Brathwaite of Ellis & Winters LLP as Attorney of Record for Covil Corporation.


