NOTICE OF APPEAL

Giles Long appeals the decision and order of the Full Commission of the South Carolina Workers' Compensation Commission dated April 30, 2019. Appellant received written notice of entry of this order on April 30, 2019.

Pursuant to S.C. Code Ann. §42-17-60, Appellant states the following grounds for appeal, while reserving the right to restate the issues in his brief in accordance with Rule 208(B), SCACR:

1. The Commission erred in failing to find that American Zurich Insurance Company had coverage for this claim.
2. The Commission erred in concluding that the American Zurich Insurance Company properly cancelled coverage for this claim.
3. The Commission erred in finding that Giles Long, as sole shareholder and owner of Metro Construction, Inc. substantially breached the terms of the insurance policy.

4. The Commission erred in concluding that the terms of the American Zurich Insurance Company policy, the notice of noncooperation and notice of cancellation were clear and unambiguous.

5. The Commission erred in failing to find that coverage under the policy was either reinstated or that policy cancellation had been revoked.

6. The Commission erred in dismissing American Zurich Insurance Company from this action.


