MOTION FOR EXTENSION


Robert W. McCaffrey, Jr., by and through his undersigned attorney, respectfully requests an extension of time for the transcripts to be ordered in the above cases. The trial in the above cases was heard the week of March 4, 2019, before the Honorable D. Craig Brown and sentence was imposed by the Honorable D. Craig Brown, on March 8, 2019, which convicted the Appellant of Obstruction of Justice. The original sentence sheet dated March 8, 2019, contained an incorrect indictment number and was amended March 21, 2019.

Appellant's Affidavit of Indigency was signed by the Appellant and notarized April 9, 2019. 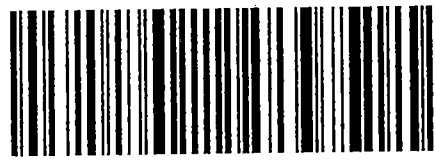
