MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

Counsel for John William Kennedy respectfully requests a **final thirty (30) day extension, until July 8, 2019**, in which to file the petition for writ of certiorari and appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The petition for writ of certiorari and appendix are due to be filed with the Court today. The Court has granted counsel two previous extensions.
2. Counsel for John William Kennedy respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Anders brief of appellant and designation of matter in the case of State v. Donnell Lakeith Davis in the Court of Appeals on April 17, 2019. Counsel filed the brief of petitioner in the case of John Willie Mack, Sr. v. State in the Court of Appeals on April 5, 2019. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Christopher Evon Smith v. State in the Supreme Court on April 1, 2019. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Willie Byrd v. State in the Supreme Court on March 5, 2019.

4. Counsel makes this request in good faith and not for purpose of delay.


5. Counsel for the Attorney General's office consents to this request as shown by signature below.
