REPLY MEMORANDUM IN SUPPORT OF MOTION TO DISMISS

COMES NOW Respondent Liberty Mutual Insurance Company ("Liberty Mutual"), by and through its undersigned counsel, pursuant to Rule 240(f), SCACR, and offers the following Reply to the Appellant's Return to Liberty Mutual's Motion to Dismiss. In support of Liberty Mutual's Motion to Dismiss, we show unto the Court following:

Appellant's Return does not dispute Liberty Mutual's contention that Appellant received the transcript of the underlying proceeding on February 26, 2019. It offers no rational basis for Appellant's failure to notify the Court of such receipt, or for Appellant's failure to submit her Appellate brief within 30 days as required by Rule 208(a)(1), SCACR.


To the extent Appellant's Return contends Liberty Mutual's Motion to Dismiss failed to comply with Rule 240, SCACR, Liberty Mutual disputes such contention and simply rests upon the form and content of its Motion as submitted to the Court and provided to the parties. To the extent Appellant's Return contends Liberty Mutual failed to provide counsel with a full and complete copy of its Motion to Dismiss as required by Rule 240(d), SCACR, Liberty Mutual disputes such contention and directs the Court to the Affidavit of Christine McBride. (Exhibit A.)

Finally, we note that Appellant's Return fails to comply with Rule 240(e) in that it was served on May 10, 2019, more than 10 days after Liberty Mutual's Motion to Dismiss was served on April 12, 2019.

Wherefore, based on the foregoing and on the underlying Motion to Dismiss, Liberty Mutual prays that this Court enter an Order dismissing this appeal pursuant to Rule 208(a)(4), SCACR.


