Dear Harry,

I hope this letter finds you well.

As you remember I filed an appeal for you after the plea on April 3, 2019. I have been in contact with the Court of Appeals on your behalf and they need more information from you.

As you know, I sent in the appeal with the explanation of the appeal as:

Pursuant to South Carolina Appellate Court Rule 203(d)(1)(B), Mr. Reese is under the belief that the Assistant Solicitor told the court that there were no warrants for original arrest and believes that these charges should have been dismissed.

The Court of Appeals followed up with me and asked if that reason had been put on the record and ruled on. I answered their letter and told them that it was not ruled on nor was the objection put on record.
