
MOTION

If for some reason this caption is deemed defective, Appellants should be substituted under SCRCF Rule 25 as real parties in interest.



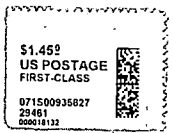
