
Dear-Ms. Kitchings:

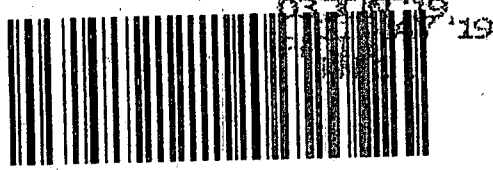

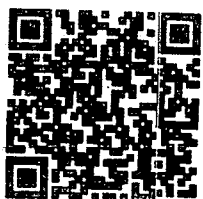
