Re: Inaccurate Transcript

Dear Mr. Young:

Now somewhat better from a virus-like condition, I am attempting to respond to the contents of a package received from you in my mailbox on January 12, 2013. The large envelope is postmarked January 5, 2013. It contains a transcript with a sheet on top held by a rubber band (see copy of your attachment) noting: "I will do AN INvoicE AND REfuNd \$22.75" with no date, signature, or initials found on the page.

Thank you finally for at least some kind of response because I actually was contemplating (upon recovery) to send you another letter of inquiry as to why I still had not received the transcript(s). Moreover, I felt a great disadvantage by no communication at all from you relative to the requested verbatim written an audio data of the July 30, 2012 and August 1, 2012 court proceedings for Order No. 2012-CP-26-4404 from the Horry County Court of Common Pleas. With no disrespect, the process of attainment as well as the final procurement is causing me some grave concerns:

First of all, the transcript includes most right but also much wrong/rearranged/unfamiliar wordings/comments. In some instances, words are actually written which I literally have never used in writing or speaking although I have two Masters degrees and lack only one paper for a Doctorate (only incomplete due to distractions via dirty politics). On page 36, for example, "... acclimated specifically for this faction ..." attributed to me is not my language and not what I ever said. I have never used the term, "acclimated" in my entire six decades. On page 45, "... designed for express purpose..." is not what I said. Other examples of misstatements include lines 11-17 on page 56; page 53, line 15 – a direct misquote; etc.. Other segments of the document are highly fragmented – seemingly as an attempt to paint me mentally deficient (perhaps to support/cover some Horry County and South Carolina State officials role in the wrongful handcuffing and transporting of me in an attempt to have me involuntarily committed in October, 2009 to mislead former Governor Mark Sanford to suspend me as Mayor of the Town of Atlantic Beach, SC). In addition, so much non-standard English found in the transcript can in no way represent what was actually said by me in or out of court. What on earth accounts for such a

discrepancy? Even under the tremendous anguish I felt that day after being forced by Judge Larry Hyman to proceed without a chance to procure a lawyer for assistance (as requested), I still could never have used terminology foreign to my normal usage.

Secondly, nothing audio is found in the envelope. Neither have you included any explanation of why the audio I paid for is not here. The main objective for the audio was my intent to have it independently also transcribed for confirmation and satisfaction by someone outside of Horry County.

In conclusion, I know you included a reference to a refund. However, I simply want what I paid for.
