

Pursuant to Rule 203(B)(iv), SCACR, I also filed an affidavit certifying I do not have a good faith basis to believe any issues are properly before the Court of Appeals and that I did not object to the sentence or file a motion to reconsider the sentence.

If you do not wish to pursue the appeal of your conviction, I would implore you to remember you have full opportunity to file a post-conviction relief action within one year of your conviction date if you believe my legal representation was deficient.
