My certiorari petition and appendix are due to be filed tomorrow for Fred Halcomb and I need to request a third extension. Do you consent to the extension request? Thanks!

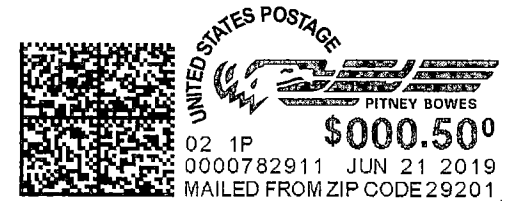
