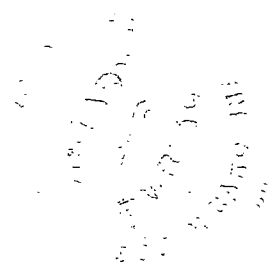

The transcripts here demonstrate the malfeasant and corruption taking place within the Unified Judicial System, not limited to the Courts of Common Pleas and abroad.


The transcripts are not just or proper based upon the facts spoken that day. As such the subject transcript must be stricken as Angela P. Berry being an officer of

WHEREFORE, please govern yourselves accordingly.



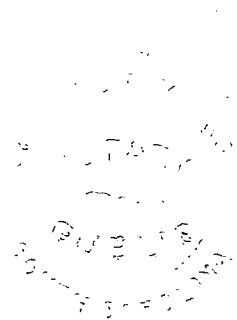


