
**MOTION TO ALLOW LATE FILING OF TRANSCRIPT ORDER





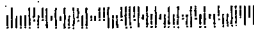
