MOTION TO RELAX COPY REQUIREMENTS


Appellant moves this Court to relax the copy requirements of Rules 210, 211 & 240, SCACR. The grounds for this motion are as follows:

1. Rules 210 & 211, SCACR, requires that fifteen copies of final briefs and fifteen copies of the Record on Appeal be filed with this Court. Rule 240, SCACR, requires that six copies of motions, returns, and replies be filed with this Court.
2. Modern technology allows for this Court and its staff to view these documents electronically and, upon information and belief, physical storage space at the Court is limited.

3. In order to conserve storage space at the Court of Appeals, reduce paper usage, and to reduce cost for all parties to this appeal, Appellant requests:

- (a) the copy requirements of Rules 210 & 211, SCACR, be reduced to filing three (3) copies (plus one unbound original) of the final briefs and Record on Appeal, and
- (b) the copy requirements of Rule 240, SCACR, be reduced to filing three (3) copies (plus one unbound original) of any motions, returns, and replies.


