


RESPONDENTS' FIRST MOTION FOR EXTENSION OF TIME





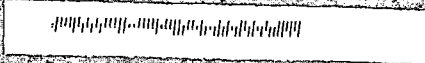
