Please allow this email to follow this morning's hearing. Judge Sprouse requested authority allowing him to consider the motion to reconsider the sentence while the appeal is pending. Please see *Hudson v. Hudson*, 290 S.C. 215, 216, 349 S.E.2d 341, 341 (1986) ("We now hold that the service and filing of a Notice of Appeal before the filing of timely post-trial motions under Rule 59 by any party does not

deprive the lower court of jurisdiction to consider the motions.”); *see also Wicker v. Anderson Cty. Council*, 289 S.C. 479, 347 S.E.2d 96 (1986); *Otten v. Otten*, 287 S.C. 166, 337 S.E.2d 207 (1985). I believe the reasoning in *Hudson* would apply in General Sessions Court. Alternatively, the appeal could be dismissed without prejudice for the Court to rule on this motion.



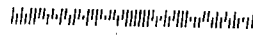
