

MOTION FOR EXTENSION OF TIME TO FILE AND SERVE FINAL BRIEFS

In support of the same, MacKenzie states that on or about June 15, 2019, MacKenzie filed a Supplemental Record on Appeal with the consent of opposing counsel. 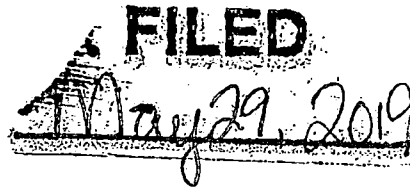



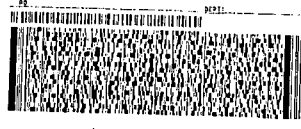
