
Petition to Extend Time to File Initial Reply Brief of Appellant





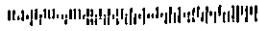
