

Counsel filed a petition for writ of certiorari to the Court of Appeals in the case of State v. Melvin Durant in this Court on May 17, 2019. Counsel filed the initial brief of respondent and designation of matter in the case of Jakarta Young v. SCDC in the Court of Appeals on May 15, 2019. Counsel had an oral argument in the case of State v. Christopher D. Campbell with this Court on May 9, 2019.

3. This request is made in good faith, and not for purposes of delay.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


