Appellant respectfully presents hereby a response to Respondent's 2<sup>nd</sup> Motion to Dismiss Appeal:

**BACKGROUND:**

1. Appellant filed notice of an Appeal on May 17, 2019.
2. Appellant files under 59 (e) but is still awaiting the prepaid transcript prior to filing Brief.
3. Appellant has responded to Respondent's motion on June 29, 2019, and July 2, 2019.

4. Appellant states that his filings are timely and has paid the court fee for notice.

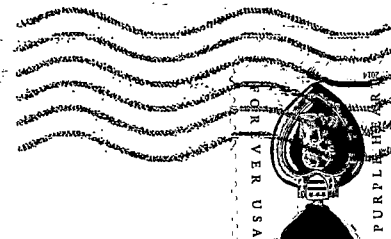
