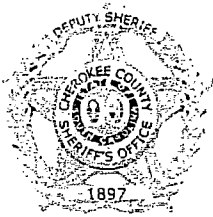

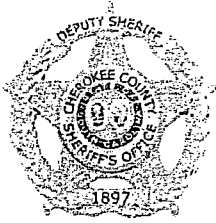

Petitioner in this case will show the Honorable Court that he pled guilty to the offense(s) of possession of less than one gram of crack, 1<sup>st</sup> Offense in the Cherokee County General Sessions Court on October 12, 2004 (2004-GS-11-925 and 2004-GS-11-926). Petitioner entered into the guilty plea under agreement and negotiations that the offenses would merge into one offense and conviction of possession of less than one gram of Crack 1<sup>st</sup> Offense.

Petitioner learned on June 30, 2017, during a motion hearing at the Spartanburg County Courthouse in regards of another PCR matter that the State would choose to unmerge his 2004 conviction and count it as two (2) separate convictions and would use the unmerged convictions to enhance his current convictions.

Petitioner files this current PCR (2017-CP-11-0486) due to this unmerging and ineffective assistance of counsel.

Petitioner will show this Honorable Court why the Lower Courts' determination was improper in light of the facts and evidence presented. Petitioner filed this current PCR Application on June 19, 2017. Respondent made its Return on or about December 1, 2017, requesting the application be summarily dismissed.

Pursuant to this request, the Court issued a Conditional Order of Dismissal signed and filed December 11, 2017, which gave the Petitioner 20 days from the date of service of said order in which to show why the dismissal should not become final.

In Response to this Order, the Petitioner filed a document titled, "Petitioner's Response to Conditional Order of Dismissal" on December 27, 2017. Petitioner had also filed a document titled, "Memorandum In Support of Post-Conviction Relief Hearing" on December 8, 2017. The Petitioner also filed an amendment to his post-conviction relief application on December 18, 2017, in which he

did amend his post-conviction relief application by stating a claim cognizable under the Post-Conviction Relief Act, which was ineffective assistance of counsel.

Applicant added to the record, criminal background reports from the Cherokee County Sheriff's Office, a South Carolina Law Enforcement Division (SLED) NCIC criminal background report, City of Gaffney Criminal History Reports, Court transcripts from a July 16, 2015 Court appearance and an Affidavit of Authentication which certified and verified that all submitted documents and records were true and correct copies of official records and reports from all said agencies. ~~App~~ Petitioner also filed another amendment to his post-conviction relief application on March 20, 2018. Petitioner would direct the Court's attention to all submitted documents, as the Court would then clearly see that there is only one conviction on Petitioner's record in 2004 for possession of crack cocaine 1<sup>st</sup> offense.

Petitioner would show the Court that he has filed his current PCR Application based on grounds of which he could not have had knowledge of by the exercise of reasonable diligence. Petitioner discovered that the State would choose to unmerge his conviction for possession of less than one gram of crack by way of a motion which was filed by the State regarding another PCR matter. This motion was filed on May 1, 2017, and received by Petitioner on May 8, 2017. This unmerging became final on June 30, 2017, during the motion hearing which was held at the Spartanburg County Courthouse.

Petitioner would direct the Court's attention to all submitted criminal background reports, as the Court would then clearly see that the conviction for possession of crack cocaine in 2004 was merged into one offense. From October 12, 2004 until present, Petitioner's criminal background reports reflect the plea agreement that the conviction would merge.


This merging could be explored also by ~~the~~ examining the prosecutor's testimony to the court in the court transcripts from Petitioner's July 16, 2015, court appearance, which Petitioner has provided for the record. (See transcripts, Page 21). There was no way that the Petitioner would have known that the State would choose to unmerge this conviction years later by exercise of reasonable diligence.

The PCR Application must be filed within one-year after the date of actual discovery of the facts or after the date when the facts could have been ascertained by the exercise of reasonable diligence. S.C. Code Ann. 17-27-45 (c)

Petitioner's claim was discovered on May 1, 2017, and he has filed his application for post-conviction relief, well within the year timeline and statute of limitations set for newly/after discovered evidence. Therefore the lower court did in fact err in dismissing petitioner's application for PCR based on expired statute of limitations. The PCR Judge's decision in the Order was an unreasonable determination of the facts in light of the evidence submitted.

Petitioner has shown and provided specific facts and reasons why this PCR Application should not be dismissed. Petitioner would ask that this Honorable Court remand this case and matter back to the lower court for appointment of an attorney and ultimately an evidentiary hearing in this matter.
