This matter comes before the Court by way of an Petition for Writ of Certiorari which was filed by the Petitioner in the above captioned case on September 24, 2018.

Pursuant to Rule 243(g) of the South Carolina Appellate Court Rules, the Return to the Petition for Writ of Certiorari must be filed and served 30 days after the Respondent has received the Petition. The Respondent in this case has failed to comply with this Rule in failing to file the Return within the 30-day allowance. The Return was due to be filed and served on October 29, 2018, and has not been filed and served at this time.

The Petitioner has received a letter dated November 5, 2018, which was submitted by Assistant Attorney General Jordan A. Cox whom represents the State (Respondent) in this case. This letter was received by the Petitioner on November 8, 2018, at the Tyger River Correctional Institution mail room. This letter, written to the Honorable Daniel E. Shearow - Clerk of Court of this Honorable Court, was a request for a 30-day extension to serve and file the Return.


The Petitioner respectfully objects to this 30-day extension while emphasizing that this request should have been served and filed prior to the 30-day (October 29, 2018) deadline.



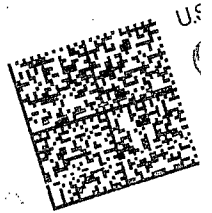
