
This matter comes before the South Carolina Administrative Law Court (ALC or Court) upon the Motion of Medical University Hospital Authority d/b/a MUSC Radiation Therapy Center - Berkeley County (Respondent or MUSC)¹ for the Court to Reconsider, Alter, or Amend its Order granting Petitioner's Motion for Judgement as a Matter of Law and Denying Certificate of Need on Other Grounds. 
