**MOTION FOR EXTENSION AS TO PETITIONERS-RESPONDENTS' RETURN TO
RESPONDENTS-PETITIONERS' PETITION FOR CERTIORARI**

Pursuant to the South Carolina Appellate Court Rules (“SCACR”), Petitioners-Respondents, I’On Assembly, Inc., Brad J. Walbeck, and Lea Ann Adkins, individually and derivatively on behalf of I’On Assembly, Inc. (collectively “the HOA”), respectfully move for Order extending the time to serve and file their Return to Respondent-Petitioners’ Petition for Certiorari (“Return”) that is due on July 22, 2019. Due to extraordinary circumstances, the HOA request this Court provide the HOA a three (3) day extension and issue an order giving the HOA until July 25, 2019 to serve and file their Return.

The HOA requests this extension because, in the past thirty (30) days since Respondents-Petitioners filed their Petition for Certiorari on June 21, 2019, the HOA has simultaneously been working on both their own Petition for Certiorari as well as their Return to Respondents-Petitioners’ Petition. 
