In regards to your letter as described above, could you please:

1. Clarify more specifically the issue(s) you and/or Chief Judge Lockemy are attempting to communicate in the second sentence which reads "Chief Justice Lockemy cannot respond to your ex parte communication, and the Court will not take any further action on your filing." For instance, and certainly not meant to limit your explanation, but as I (admittedly a non attorney) understand it "ex parte" means one party and is mostly considered an issue when all of the parties are not included in a communication, especially with a judge. I'm fairly sure I included everyone and then some on that email.
2. In the sentence that states "We have also received your motion dated July 7, 2019, which we construe as a motion to reinstate your appeal.", while not disputing the essence of the motion, just like since mid January of this year, or potentially early November 2018, is to reinstate the appeal, that certainly is not the only issue involved. Could you clarify that the Court construes the overarching significance of the motion correctly. Since McCabe Trotter hasn't sent me anything yet arguing on y'all's behalf, I'm concerned.
3. Why does the title say "Churchill Park v Alan G. Nix AND Churchill Park v. Alan G. Nix"?

Thank you in advance for your response. I would have gotten this out earlier but have been super busy dealing with a (ironically?) related matter down here in Charleston / Mount Pleasant. I copied Judge Lockemy on that too, but it was just to make sure he was aware, no response expected at this time.

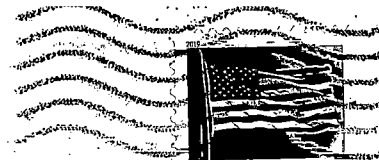
