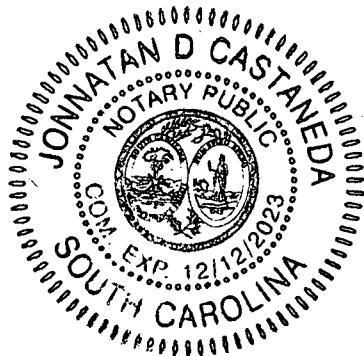

Personally appeared before me, William Brandon Bell, who being duly sworn, swears and deposes that if he was called as a witness he would truthfully and accurately testify as follows:


