THIS CAUSE coming before and being heard by the undersigned Judge on January 28, 2019, on motion of Plaintiffs Katkams Ventures, LLC and Suprema, LLC (collectively "Plaintiffs"), successors in interest to 521, LLC, for the Motion for Summary Judgment, filed on November 12, 2018. Based upon the pleadings, the affidavits, and the discovery responses, it appears to the Court that Plaintiff Motion for Summary Judgment should be GRANTED:

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:

1. That no genuine issue of material fact exists in regards to Plaintiffs' claim for Breach of Contract against Defendant No Limit, LLC, d/b/a No Limit Financial, LLC (hereinafter "Defendant No Limit");
2. That no genuine issue of material fact exists in regards to Plaintiffs' claim for Breach of Contract – Guaranty against Defendant Erich Simpson (hereinafter "Defendant Simpson");

3. That the Plaintiffs' Motion for Summary Judgment shall be **GRANTED** in favor of the Plaintiffs' favor based upon their claims of Breach of Contract against Defendant No Limit and Breach of Contract – Guaranty against Defendant Simpson; and

4.
