
AMENDED NOTICE OF APPEAL





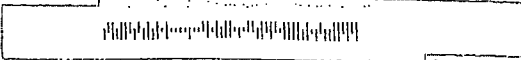
