2. Due to multiple court appearances, in and out of town, Respondent's counsel has not

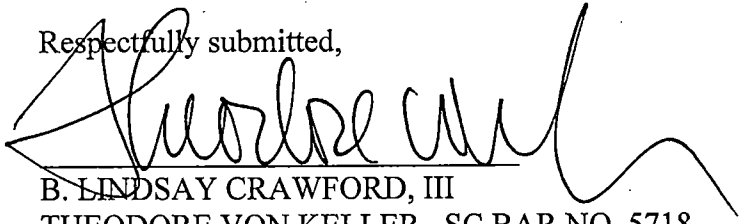
had time to draft the brief in this appeal.

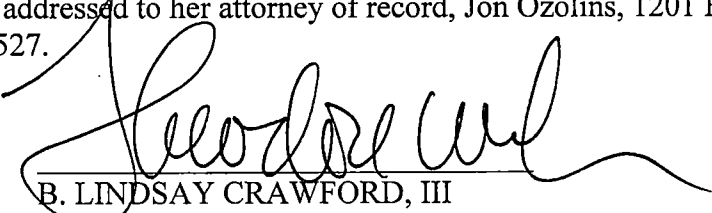

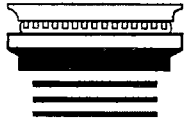

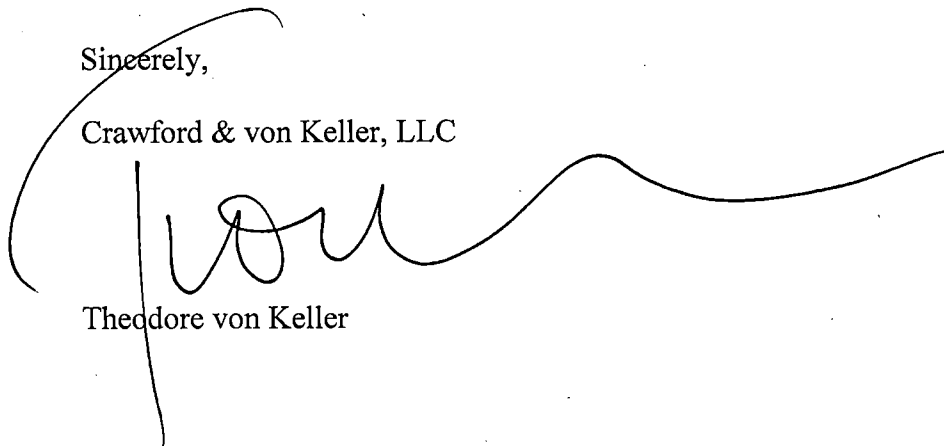
