I am writing all parties interest in the above-captioned matter to determine the Status quo of this case. Please take notice of previous actions taken;

- Applicant timely filed his Post-Conviction Relief (PCR) application on February 17, 2011.
- An evidentiary hearing convened before the Honorable Edgar W. Dickson, PCR Judge, at the Lexington County Courthouse on August 15, 2013.
- Judge Dickson re-convened evidentiary hearing on November 13, 2014.
- Respondent, Attorney General, filed and Served PCR court's 'Order Granting Belated Appeal' on February 2, 2018.
- Respondent timely filed a Rule 59 motion to 'alter or amend judgment' on or about February 10, 2018
- Applicant prematurely filed a Notice of Appeal on or about February 12, 2018.
- The Supreme Court dismissed the appeal without prejudice pursuant to Hudson v. Hudson, 290 S.C. 215, 349 S.E.2d 341 (1986) on August 13, 2018.
- The Remittur was sent down to the lower Court on August 31, 2018.

Applicant Now Comes respectfully requesting a ruling on Respondent's Rule 59 motion, so that applicant's appeal may be perfected by appointed Counsel and presented to Supreme Court for adjudication in accordance with Due Process of Law.

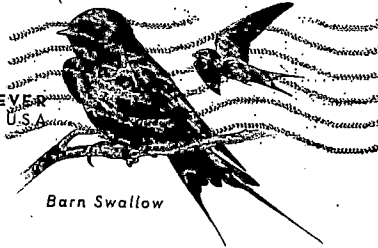

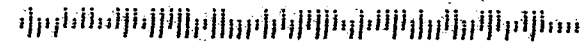
