

On November 26th, 2016 in the Conway section of Horry County, the defendant, along with several co-defendants, did order the victim, Chris Schmidt, out of his vehicle at gun point and tell him to have the clerks open the door. Once inside, the defendants did order the patrons to the ground and demand the money from the registers and safe to be put in a backpack. The defendants then fled the scene and were stopped a short time later, and attempted to throw the backpack containing the money out of the window. R/O DJ DUDLEY
