

Henderson on July 26, 2019 on indictments 2016-GS-17-0875, 2016-GS-17-0877, 2016-GS-17-0878, 2016-GS-17-0879, for Attempted Murder (2 Counts), Kidnapping, and Possession of a Weapon during Commission of a Violent Crime. 

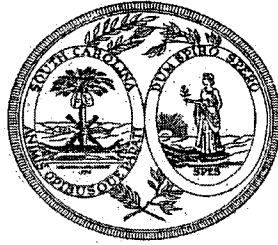

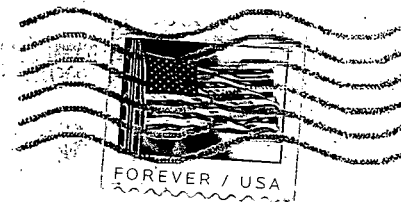
