


I waited to send proof of service until I received the return receipt. I asked for an extension because I had to get another copy of the transcript that's why everything else was sent by July 26th the extension date I received.

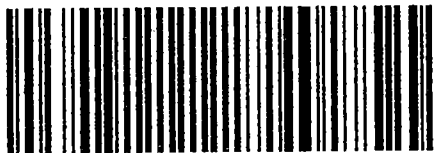
