

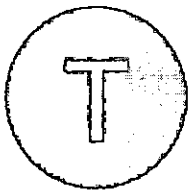
**MOTION TO STAY PROCEEDINGS**
