The undersigned counsel respectfully requests a **final thirty day extension, until March 11, 2013**, in which to file the initial brief of appellant and designation of matter in the above-referenced case. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Tito Harris in this Court on December 7, 2012. **Counsel also has extensive administrative duties as the Chief Appellate Defender.**


3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will

hopefully become more manageable in the near future, and less extensions will need to be requested.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


