following grounds.


The opening brief and designation of the record is due to the Court on August



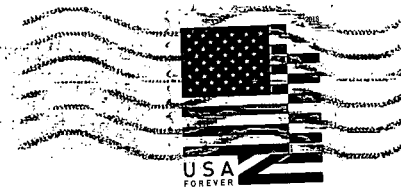
