To Go To The Police She Said She Could Not Because They Would Say She Set Up The Whole Thing She Said If Something Ever Happen To Her Then I Know What To Do Some Times Janice Been The Truth On Stuff. I Do Remember Janice Saying She Still Couldn't Stand Keith Lewers For Things He Done To Her They Had Issues Way Before I Came A Long Thats Why Me And Janice Couldn't Be Together Because They Was Still Married I Didn't Know Until He Called Playing On The Cell Phones One Night Mad At Janice Cause Of Me Calling Her Bitches & Whores Her Family Was Scared Of Him, Mother, Sister, Sons, And Brothers I Said To Keith Look You Can't Be Stressing Her Out Because She Might Be Pregnant He Bust Out Laughing Saying Man That Bitch Can't Have Any Babies So I Gave The Phone Back To Her Because I Couldn't Believe She Lied To Me Our Little Relationship Faded, I Have Been Knowing Janice Since 1996 We Didn't Date Until 2009 For About 11 Months. Janice Said She Got Keith Set Up To Get Robbed For A Rolex Watch One Night At Some Gas Station And They Took His Car Keys He Called Janice Cause She Had A Set To His Car He Didn't Have Any Money She Said Laughing Calling Him A Broke Ass I Told Her I Didn't Want To Get On Her Bad Side She Was At The Bar And Met A Guy And Some Of His Friends She Had A Big Block Party They Was There Now I Don't (2)

Know What Is What But I Have
Been Robbed Over Three Times Once In
Front Of My Apartment Complex By Two
Females And Two Guys At Gun Point They
Took My 2 Chains, Cell Phone, Money, 4
Rings And A Blue Face Rolex Watch The
Second Time Was At My House They Broke
In One Night When I Was Gone Over Nite
They Took Over 30 Pair Of Shoes Brand New
Clothes, 20 Hats, "50" Inch Big TV, Shot Gun
And A Big Link Necklace The Police Came
Out But They Didn't Get Any Prints Sad Part
Was They Missed The Money \$20,000 Dollars I
Had In My Son Old Coat The Third Time
Was When I Got Robbed At Janice House
3-16-14 For \$15,000 Dollars, 4 Diamond Rings,
Watch And A Necklace The Guy Said "We Been
Trying To Get Your Ass Nigga" I Always Had
Money I Lost My Father In 2002 To Brown
Lung Cancer So I Got A Settlement Check
And On 10-21-12 My Mom Died Of Heart
Failure I Received \$20,000 For Her Death
I Had Cars, Trucks, Motorcycle, Money And Jewelry So
People Know Me, Family & Friends Know Me
Because I Looked Out For A Lot Of
People I Worked On A Real Job Driving
A Sit Down Forklift For Magna They Made
Car Parts For BMW I Worked 10 (3)

To 12 Hours A Day 7 Days Making 600. To 800. Weekly And I Always Saved My Money I Was A Great Father And Took Care Of My Kids An Seen Them Everyday I Had Just Got A New 3 Bedroom House With A Big Yard For Them A Great Location Bout 3 Minutes Up The Street From My Kids Grandmother House. They Made Up Lies About Me And Janee Being Together Which Was Not True We Have Been Friends Since 1996 People Don't Even Know That I Left Greenville S.C. 2000 And Moved To North Carolina Then Moved Back 2005 I Ran In To Her One Evening When I Was Going To The Store She Was Sitting On Side Of The Store Cussing With Somebody Saying Something About Gas Money When She Got Off I Said Hey Pull Up To The Pump And I'll Get You Some Gas We Was Friends After That We Dated Not Even A Full Year April 2009 - March 2010 Maybe 10 Or 11 Months I Broke Things Off Then I Met My Fiance'e Kemiko Mitchell And We Was Together 5 Years Yep We Had Dur Problems Break Ups To Make Ups I Dated 3 Other Women Crystal For About 8 Months That Ended Next Was Clarrisa From North Carolina My Mom Loved Her And Wanted Me To Be In A Relationship With Her But After She Passed Away Clarrisa Said I Was Acting Funny But I Was Hurting Because Of Losing My Mother My Best Friend So I Just Stayed To Myself That's When I (4)

Met Shelia Martin The Lady Who Drove Me To The Hospital's We Dated For 10 Months And I Broke Up With Her To Get Back With Kemiko I Really Loved Her And Changed My Wife Around Because I Wanted Something Real A Woman Who Really Loved Me And My kids Thats When I Got On One knee Pulled Out A Diamond Ring And Asked Her To Marry Me She Said "Yes" I Put The Ring On Her Finger We Went From There Building A Strong Healthy Relationship For Us And Our 5 Boys I Would Never Give That Up For Nobody And I Never Been A Abusive Man To Any Females, My Kids Or Any Body Else kids They Will Tell You That About Me. The Lead Investigator Michael Fortner Committed Perjury When He Took The Stand And Lied Under Oath About Me Saying I Told Him That Me And Janice Was In A Relationship And She Was Trying To Cut Me Off I Never Said Nothing Like That I Liked Her As A Friend Nothing Sexual Nothing More He Flashed My Cell Phone To See If I Was Hacking In To Her Text Messeges Which Was False The Sister Made Up A Lie About Me Using Some Type Of Spyware I Don't Know What (5)

It Is Something With A Cell Phone Or Computer Either Way It Was A Lie Just Like Everything Else They Made Up There Is A Text In My Phone Telling Janice I Wasn't In Love With Her Anymore But They Hid That Text To The Jury Now If She Was So Called Scared Of Me Then She Wouldn't Have Been Picking Up My Son From School When I Was Working Late She Volunteered To Pick Him Up And Bring Him To Me We Would Meet At Mc Donalds And I Would Give Her Gas Money. I Was Getting Ready To Change Schools For My Son So He Could Be Close To Me And His Grandma Debra With Picking Him Up So I Could Work Over Time Janice Son And My Son Was Going To The Same School But When Keion Got Beat Up And Locked Up I Told Her I Was Changing Schools Before Keion Comes Home She Asked Why I Said Kempko And My Kids Mother Wanted That And Didn't Want Keeshun Around Keion Because He Was A Trouble Maker. To Keion Lewers He Had Just Got Of DJJ - Department Of Juvenile Justice For The Second Time A Place Where Bad Kids Go When They Rob, Kill, Steal, Drugs, Fires And Can't Stay Out Of Trouble He Was In & Out Of Jail For Robbery And Drugs Janice Could Not Handle Him Anymore He Was In To Gang Violence He Got Beat Up By Another Gang Set Which They Broke His Ribs, Wired His Mouth Shut He Had (6)

Why I Took Off Running For My Wife I Went From
A Victim To A Witness To A Suspect All Over

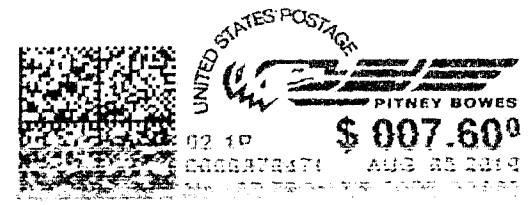

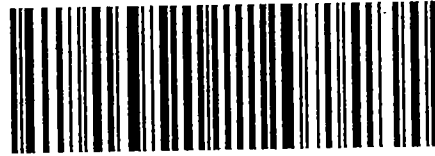
