On March 21st, 2019, Plaintiff/Appellant filed its Initial Reply Brief of Appellant. On March 29th, 2019, Plaintiff/Appellant filed its Record on Appeal. On April 1st, 2019, Plaintiff/Appellant filed another Appellate Reply Brief and Appellate Brief. On April 5th, 2019, Defendant/Respondent filed a Final Brief of Respondent.

Plaintiff/Appellant's Motion for Appeal was heard by This Court in Cherokee County. On May 13th, 2019, This Court filed an Order denying Plaintiff/Appellant's Motion for Appeal. Plaintiff/Appellant filed its Motion for Reconsideration on May 28th, 2019. Defendant/Respondent filed a Response to Plaintiff/Appellant's Motion for Reconsideration on June 7th, 2019.

CONCLUSION

After careful consideration of the able arguments and filings of Counsel and review of the record, The Court is unable to discover any material fact or principle of law that either has been overlooked or disregarded and further finds no error of law or fact not appropriately considered.
