NOTICE OF APPEAL





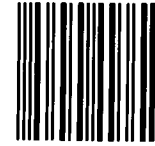
