
MOTION FOR COSTS

Pursuant to Rule 222, SCACR, Norwest Properties, LLC, requests that the costs of this appeal be taxed against Respondents Michael T. Strebler and Lisa W. Strebler. Rule 222(a) provides that, unless the Court orders otherwise, “[w]hen a judgment is reversed, costs shall be taxed against the respondent.” Rule 222(a), SCACR. This Court reversed the judgment of the circuit court on August 1, 2018. On June 28, 2019, the Supreme Court denied Respondents’ petition for writ of certiorari. On the same day, this Court issued the Remittitur. Because the Court has not ordered otherwise and the parties have not agreed otherwise, Rule 222 provides that the Court should award costs to Appellant Norwest Properties, LLC.

In accordance with the instructions of Rule 222(d), an itemized statement of costs is attached to this motion.





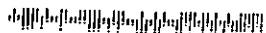
